- A completed application. To complete the application, you must save it to your computer. Be sure to save as you go and upon completion to ensure your progress is captured. It is recommended that you retain a copy of this application for your records.
- Your Curriculum Vitae (CV), no more than three pages in Word or PDF format, minimum 10 pt. font. CVs may include information regarding leadership and volunteer experience, education, professional experience, membership in professional organizations and any special awards you believe are relevant to the position in which you are applying, as well as a professional headshot should you wish to submit one. Please note that if more than three pages are submitted, only the first three pages will be provided for consideration.

Once your application has been submitted, you will receive an email confirmation. Any changes to the application or CV must be submitted prior to the deadline.

Position summary

In 2023, the house of delegates adopted a resolution modifying the speaker of the house election process to elect a nominee for speaker-elect the year prior to the expiration of the incumbent speaker's term, allowing the incoming speaker to shadow the incumbent speaker for a year before taking office. CDA is soliciting applications for the 2026-2028 speaker term, with shadowing to occur in 2025.

Election process

Candidates for the speaker-elect position submit their application to the Committee on Volunteer Placement for confirmation of eligibility, are nominated by the CDA Board of Directors and elected by the CDA House of Delegates the year prior to the expiration of the incumbent speaker's term. Candidates will be invited to attend the August 23, 2024 board meeting, at which time nominations will be conducted.
