## Regular Business

- 1. <u>Chair Report</u>: Dr. Graham gave updates on the board roster updates and welcomed De'Brae Gaines to the foundation staff.
- 2. <u>Executive Director Report</u>: The board received a verbal updated from Mary McCune, executive director, on the Wellness Committee's continuing education session at CDA Presents in Anaheim and encouraged members to attend. Mary also shared that the Community Based Clinical Education contract has been fully executed between the foundation and the office of oral health.
- 3. <u>Ukraine Relief Fund</u>: Marissa Allen, foundation manager, gave an update on the final fundraising total and items to be shipped to Ukraine.

5. <u>Webb Family Grant:</u> Gabriela Garces, Grants and Awards Committee chair, provided background on the Webb Family Grant and the committee's recommendation to adjust the guidelines for the grant to ensure continued support of people in the dental profession.
