

## 2025 Medi-Cal Dental Rates with Prop. 56: Most Utilized Dental Services in Medi-Cal Dental for Adults and Children

In California, after the passage of Prop. 56 in 2016, a portion of funds raised were used to apply an additional rate to hundreds of dental codes. Most Prop. 56 rates range from 20 - 60% of the existing scheduled maximum allowance (SMA), with 40% being the most common percentage. Some codes receive a flat rate to bring them up substantially higher to incentivize increased utilization and care. Below is a chart with the most utilized current dental terminology (CDT) codes with the Prop. 56 rates compared to the average 2024 out-of-network (OON) rates for general dentists.
